Benefits of Membership

Ordinary member

- The subscription fee for Ordinary Membership is \$20 per person per year.
- Ordinary Members are able to vote at Special or General Meetings of the Association.
- Ordinary Members are eligible for election to the Management Committee.
- If an Ordinary Member is actively involved in a production as a cast or crew member, they are entitled to receive a voucher for two complimentary tickets for any performance of that production **AND** two complimentary tickets for any performance of the subsequent production.

Temporary member

- The subscription fee for Temporary Membership is \$10 per person per production. [Temporary Membership allows for members of the cast and crew of a particular production to be members of the Association for the period of that production. Their membership shall cease two weeks after the date of the final performance.]
- Members of the cast or crew are required to be members of the Association. At its sole discretion the Management Committee may choose to waive the subscription fee that is payable to become a member.
- Temporary Members are entitled to receive a voucher for two complimentary tickets for any performance of the production with which they are involved **AND** two complimentary tickets for any performance of the subsequent production.
- Temporary Members are *not* able to vote in at Special or General Meetings of the Association.
- Temporary Members are *not* eligible for election to the Management Committee.

Approval of Membership

- The Committee of Management of Galleon Theatre Group Inc. is responsible for approving applications for membership.
- Membership of Galleon Theatre Group Inc is conditional on the member maintaining active involvement with the organisation. The Committee will not approve applications for ordinary membership or temporary membership unless the applicant is **actively involved** in the administration/ management of the Group and/or is actively involved in the cast and/or crew of that year's productions.
- If your application for membership is approved the Committee of Management will issue a receipt for your remittance and provide it to you, otherwise your remittance will be refunded.
